

### MANAGER'S REPORT

Let's take a moment to reflect on the past year at Lillian's and all the team and the girls have achieved.

I would like to extend my heartfelt gratitude to our community, including our generous donors and service partners. Your unwavering support is invaluable and plays a crucial role in helping Lillian's accomplish our mission. Lillian's operates with minimal funding and relies on the goodwill of donors and collaboration with other agencies to coordinate the care of some of the communities most vulnerable girls and young women that call Lillian's home.

In the time I have spent at Lillian's I have witnessed some incredible outcomes achieved by our girls. Utilising brokerage funds we have established girls and young women in independent living, purchased furniture to establish homes, accessed health supports, assisted with the cost of transport and ensured our girls have the technology required to participate in educational and vocational programs.

Our partnership with Youth off the Streets (YOTS) through our Subcontract Agreement has flourished, enabling YOTS to offer vital support as needed. This fosters collaboration that benefits both our organisations and, most importantly, the girls and young women at Lillian's. Likewise, our alliances with Metro Housing and Good Shepherd have remained strong, reinforcing our steadfast commitment to the girls and young women we serve.

A new partnership with Births Deaths and Marriages has ensured fast tracked identification for our young women. Without ID you can't open a bank account, apply for Youth Allowance or transitional housing. Prior to this partnership it could take as long as three months to obtain a birth certificate severely limiting the time we have to access essential services such as Centrelink payments for our girls.

To my inspiring, hardworking staff and volunteers I would like to acknowledge the professional trauma informed care they deliver daily.



Working in the homelessness sector is difficult at the best of times but working in a 24/7 setting is challenging for all staff, their commitment, humour and collegiality is what has kept the service operating.

As a cohesive staff team, we actively participated in numerous meetings, sustaining our valuable partnerships and keeping ourselves well-informed about policy updates and other changes. These engagements highlight Lillian's commitment to collaboration and staying informed about various aspects of our work and the community we support. We've supported four students pursuing degrees in Social Work and Diploma in Youth Work and Community Services, assisting them in completing their work placements at Lillian's.

The dedication and hard work of the Management Committee has been truly exceptional this year. Your abundant talent, generosity, and skill have been instrumental in the success of Lillian's, fostering significant growth and positive change for the resilient girls and young women we serve.

Lastly, I would like to acknowledge the incredible girls and young women accessing our services. The resilience and courage demonstrated daily is what keeps us in the job. The girls are welcoming to all new residents and go above and beyond to provide peer support to other girls entering the program. They are facing challenges that no young woman should have to face, and I love watching the transformation of these young people as they settle into the refuge and surrender to the safety and security of Lillian's life.

# ADINA'S LETTER

My time at Lillian's has been a journey of growth and development and I am so grateful to be able to reflect and share my experience with you all.

My name is Adina, I moved to Lillian's around a year and a half ago, when I was 16 years old. It was my first refuge, and I was terrified, but it would be the best thing that had happened to me, especially at such a low time in my life. Now that I look back on it, I remember how daunting it really was. I had no idea what to expect and every day leading up to my move in date was filled with tears and relentless anxiety. Even after I had settled in, the rigid feeling in my chest still lingered for weeks. Luckily, the staff were always there for me. They took the time to reassure me that everything was okay, and it was! I was safe, and in the best place that I could be.

Living at Lillian's has helped me learn so much, coming from a very strict home where I had little to no freedom. My mental health was never taken seriously with my family, so living here made me realise that my feelings and what was happening inside of my head mattered. I will forever appreciate that I am validated here — I can finally feel okay with knowing that I am a person who struggles with mental health and that I have the support that I need to overcome it.

Across my time living at Lillian's, the biggest struggle that I had was finishing high school. Every day, waking up to go to a place that I had such a hatred for was unbearable, and if it wasn't for the staff who encouraged me to keep my head up in the last leg of school, I would have never graduated. Thanks to Lillian's, I was also introduced to countless opportunities, such as scholarships and career positions that will help me continue my studies and pursue my dreams to go to art school, and I feel so lucky and thankful for this.

One achievement that Lillian's saw through was my struggle with nicotine addiction. At the time of writing this, I am 400 days sober! This was only made possible with the assistance of staff who congratulated me at every milestone I reached, which kept me on track so that I would never give up. Nicotine was my unhealthy form of anxiety management, but soon after I stopped, I realised it was quite the opposite. Since I have quit, my anxiety symptoms have eased and through therapy I have learnt healthy coping strategies that I will carry with me for the rest of my life.

I have met so many amazing women and girls through this program, and these are connections that I know I will never let go of. It is crazy to think that I came here at only 16 but now, I am leaving as an adult and moving into Lillian's transitional accommodation, and I am so excited to visit whenever I can, whether for casework or house outings. I truly believe that I have grown so much as a person since moving here. A year and a half ago, I was a fragile, shy and nervous girl.

Now, I am a powerful and independent woman who is ready to step out into the world and live my life with certainty.



Hi! My name is Ebbany im 15 years old.

Growing up wasn't an easy thing, I had to grow up quickly. Before the age 8 I was already cooking and cleaning for myself, I had never experienced being a kid and having things done for me and being able to make mistakes. I became independent and mature very quickly. I learnt everything the hard way. I wasn't spoon fed like all the other kids around me and this made me feel alone and the odd one out.

I became homeless at the age of 14.. I was running away from home from the age of 13 due to emotional and physical abuse at home. I lived on the streets for about 2 months till I finally gave up and went to a police station. Then I was moving from house to house. I didn't feel human. I was being passed around and thrown out of houses like rubbish. No one wanted me. Finally DCJ took me into their own hands and placed me in a hotel with youth workers. I felt alone. I thought that this was the end and no one was ever going to want me.

I was wrong. The day I got an interview with Lillians I saw hope although I didn't know what to expect. As I got so used to feeling alone. This was different. The open arms Lillians gave me when I first walked in the door made me feel warm and fuzzy inside, a feeling I was very unfamiliar with, it was a nice feeling.

I was very lucky to get into Lillians for many reasons. The main reason is that its local to the areas I've grown up my whole life, which made me a lot more comfortable with the idea of a refuge. My first official night of living here was the day I felt safe, something I haven't felt in a while. The staff and the girls living with me at the time were all very nice and welcoming. I've been at Lillians for just over a year now. Lillians isn't just a 'refuge' it's a home, a family and a safe place for young women to feel loved, supported and cared for.

The support Lillian staff provides to us girls is never ending. They encourage all our dreams and wishes and will always provide support for us!

Without Lillian's ongoing support and encouragement to move forward and accomplish my dreams I wouldn't be here today. Lillians hasn't only provided me with a roof over my head but a caring loving family.

I wanna thank all the staff for all their support, blood sweat and tears to make this house a home.

I wanna individually thank my case worker ruby for everything she's done for me. She's helped me become who I am today.



### SYDNEY'S LETTER

Hi, my name is Sydney and I'm 20 years old.

I was raised in Vietnam in a very dysfunctional household. Life was tough, and when I was offered the chance to move to Australia for a new beginning, I thought it would be a fresh start—a way to leave behind all the bullshit. But I found myself walking on eggshells, trying my best to not get kicked out.

There were times when I felt completely lost and alone. One day, I finally got the courage to knock on the school counsellors door and confided about what was happening. She was the first person to tell me about refuges, and that's when I learned about Lillians. I remember watching the Lillians introduction video with Viv talking about how they support girls like me. I'd be crying, wishing I could be there, thinking, "This place sounds incredible." But I thought I wasn't struggling enough to be there.

Eventually, I was kicked out, and I applied to Lillians. Unfortunately, they didn't have any vacancies at the time, so I ended up staying in different refuges. While I was grateful to have a place to sleep, most of those refuges were chaotic and full of drama. It wasn't ideal, but it was better than being out on the streets.

After a year or two, I applied to Lillians again, and this time, I got in. It was one of the best things that ever happened to me. I even reconnected with Ruby, who had been a worker at one of the previous refuges I stayed at. Ruby became my caseworker and has been incredible in helping me get my life together and build a future for myself. She's been relentless in teaching me the importance of self-love, always reminding me that I am worthy and deserving of good things. Her persistence and support have made all the difference, helping me believe in myself and embrace the journey ahead.

The entire team at Lillians welcomed me with open arms, showing me a level of care and understanding that I had never experienced before. Thanks to Lillian's, I got to become a turtle mother of two little boys, Michael and Squirtle. They're so cute, and I absolutely love having them in my life. The Management Committee also gave me the opportunity of a lifetime—a trip back to Vietnam! They noticed I had lost touch with my culture and wanted to help me reconnect with my roots, I'm going in January and I am bit scared but also very excited.

Lillians has been more than just a refuge to me. It's been a home, a family, and a place where I've been able to heal, grow, and find hope for the future. I've learned so much about myself and what it means to truly live, not just survive.

To Ruby, the team at Lillians, and everyone who continues to support this incredible refuge, thank you from the bottom of my heart. You've given me the stability and strength I needed to build a new life, and for that, I will always be grateful. Thank you.

# THE GIRLS' ACHIEVEMENTS



To our beautiful girls who are facing challenges that no young woman should have to face, we love watching the transformation of these young people as they settle into the refuge and surrender to the safety and security of Lillian's life. Their daily motivation and the humbling experiences they provide are the driving force behind our unwavering commitment and hard work. Their achievements are remarkable and a constant source of inspiration and serve as a testament to their extraordinary potential.

17 girls moved out of Lillian's this year. They either moved into independent living/transitional housing, the private rental market or back into the family home. We had one girl transition into Lillian's transitional properties with Metro Housing, two moved into private rental, one exited to long term mental health service and eight exited to other refuges.

We had one resident volunteer her time to work at the Sydney Royal Easter Show this year and one resident was employed to work on developing an app to assist those quitting vaping. That resident has also quit vaping herself, which is a huge achievement in itself!

Oh - and some of the girls met Dave Grohl from Foo Fighters!

### TREASURER'S REPORT



During the 2023/2024 financial year, Lillian's received an amount of \$604,064 in funding from the Department of Communities and Justice (DCJ) through our subcontract arrangement with Youth off The Streets. Sadly, our financial records indicate that we incurred an operating loss of \$222,000 specifically in relation to the funding received from DCJ. This loss can be attributed to a significant increase in staffing expenses, which amounted to \$736,000, representing 100% of our total budget. It's important to note that these staffing expenses were deemed necessary to appropriately staff the refuge, aligning with best practices in service provision.

Lillian's equity position, however, remains robust, amounting to a sum equivalent to one year's worth of ordinary services expenses. We embark on the next financial year, from a solid financial standpoint with all accruals and provisions in place, and we possess a healthy equity of \$545,183.

We remained committed to our fundraising initiatives, harnessing the potential of our Give Now donations page and with the support of numerous individuals, played a pivotal role in this endeavour. Thanks to their unwavering dedication and the generosity of our supporters, Lillian's total revenue for this fiscal year reached \$141,797 with a substantial contribution of \$86,000 coming from the Give Now donations page.

I am delighted to share that Lillian Howell Project Inc maintained a robust financial standing throughout the 2024 financial year. This accomplishment can be credited to the diligent efforts of Lillian's team and Management Committee, who exercised careful control over expenses and harnessed the strength of our balance sheet to invest in capital expenditures, enhancing overall productivity. As of the present, Lillian Howell Project Inc's financial position and reserves remain solid. All projects and grants were fully utilised, and all legal accruals and entitlements have been duly accounted for. This reflects our commitment to responsible financial management and our dedication to meeting all our financial obligations.



### **Principal Activities**

The principal activities of the association during the financial year were: The provision of a specialist Homelessness service providing medium to long-term 24 hour supported accommodation for young women and girls 13 - 17 years, that is trauma informed, reparative and empowering. As well as providing a safe and secure setting, Lillian's builds the capacity of the girls and young women and supports them in their transition to independent living..

#### Service approach includes:

- Intervening early to prevent homelessness by promoting awareness of the causes of homelessness and
  working closely with 'first-to-know' services (e.g., schools, housing providers, correctional facilities,
  domestic and family violence services, child and family services and other services) to identify people at
  risk of becoming homeless
- Providing a medium-term response by offering medium-term accommodation with 24/7 support in our refuge and traisitional properties including ongoing case management
- Providing intensive responses for clients with complex needs through intensive, multi-disciplinary support to girls and young women at risk of chronic homelessness as well as assertive outreach

### Significant Changes

No significant change in the nature of these activities occurred during the year.

### **Operating Result**

The loss from ordinary activities after providing for income tax amounted to \$91,995.17.

#### Report on the Financial Report

I have audited the accompanying financial report, being a special purpose financial report, of Lillian Howell Project Incorporated (the "Association"), which comprises the Committee's Report, Statement by Members of the Committee, Income and Expenditure Statement, Balance Sheet, notes comprising a summary of significant accounting policies and other explanatory notes for the financial year ended 30 June 2024.

These additional procedures included obtaining an understanding of the internal control structure for fundraising appeal activities and examination, on a test basis, of evidence supporting compliance with the accounting and associated record keeping requirements for fundraising appeal activities pursuant to the Charitable Fundraising Act 1991 and Regulations.

It should be noted that the accounting records and data relied upon for reporting in fundraising appeal activities are not continuously audited and do not necessarily reflect after the event accounting adjustments and the normal year-end financial adjustments necessary for year-end financial report preparation.

#### **Audit Qualification**

It is not always practicable for the Association to establish accounting control over all sources of fundraising appeal activities prior to receipt of these funds by members of the Association and accordingly it is not possible for my examination to include procedures which extend beyond the amounts of such income recorded in the accounting records of the Association

However, based on my review of the internal controls, nothing has come to my attention which would cause me to believe that the internal controls over revenue from fundraising activities by the Association are not appropriate.

### Qualified Audit Opinion pursuant to the Charitable Fundraising Act 1991

In my opinion, except for the above qualifications:

- (a) the accounts give a true and fair view of the financial result of fundraising appeal activities for the financial year ended 30 June 2024;
- (b) the accounts have been properly drawn up, and the associated records have been properly kept for the period from 1 July 2023 to 30 June 2024, in accordance with the Charitable Fundraising Act 1991 and Regulations;
- (c) money received as a result of fundraising appeal activities conducted during the period 1 July 2023 to 30 June 2024 has been properly accounted for and applied in accordance with the Charitable Fundraising Act 1991 and Regulations; and
- (d) there are reasonable grounds to believe that Lillian Howeli Project Incorporated will be able to pay its debts as and when they fall due.

### Qualified Audit opinion on the financial accounts
